Dear Property Owners:

In order for you to continue the renewal process of your Williamson Act application, pursuant to Resolution 106-04, you will need to provide an accurate legal description of the property. The deed for the property is from April 1949 and does not adequately describe the parcel involved in the new contract. There have been resubdivisions and Assessor Parcel Number changes involving your property since your last contract was recorded. To continue your Williamson Act contract, renewal Liwill need an accurate legal description of the property to be included in your new contract. You can do this through a title company or a surveyor's office. Please label the legal description as "Attachment A".

You will have until June 13, 2009 to provide the accurate legal description of the property and provide an updated Agricultural Management Plan of your proposed use of the property. Failure to provide the requested information by this date will result in the County initiating the filing of a Notice of Nonrenewal on Assessor's Parcel Number 31-010-02.

Once the legal description has been completed and returned to the Community Development Department and the updated Agricultural Management Plan has been received, the renewal of your Williamson Act application can continue.
