### **FACTUAL ALLEGATIONS**

- 12. On or about November 2007, Mr. Ventimiglia began living in a cabin on a subdivision owned and operated by Defendants. Mr. Ventimiglia lived there without incident for over sixteen months.
- 13. While living at Defendants' subdivision, Mr. Ventimiglia provided services in the form of odd jobs to other residents of the subdivision as well as surrounding cities. He developed a substantial customer base.
- 14. Plaintiff is informed and believes, and based thereon alleges that on or about April of 2009, Defendants became aware that Mr. Ventimiglia's picture and/or information was on the Megan's Law Website.
- 15. Plaintiff is informed and believes, and based thereon alleges that between April of 2009 and December of 2009, Defendants made prohibited use of the information from the Megan's Law Website concerning Mr. Ventimiglia, by using the information for purposes relating to employment, benefits, privileges, or services provided by any business. Defendants use of the Megan's Law Website information is a "use of information disclosed pursuant to this section for purposes other than those provided by paragraph (1) or in violation of paragraph (2)" making Defendants liable for damages per Penal Code § 290.46(1)(4).
- 16. Plaintiff is informed and believes, and based thereon alleges the following: the Board of Directors of Defendants, using information from the Megan's Law Website, disseminated such information to the residents of Defendants' subdivision and the residents of the neighboring cities in order to preclude Mr. Ventimiglia from working for anybody there or in the surrounding areas, voted to stop Mr. Ventimiglia from being employed by the Defendants, voted to have Mr. Ventimiglia's name removed from advertising on Defendants website and pressured Plaintiff's landlord to evict Mr. Ventimiglia.
- 17. California law specifically prohibits using the information published on the Megan's Law Website "for purposes other than those provided by paragraph (1) or in violation of paragraph (2)" of Penal Code § 290.46(1).

- 18. At all times relevant to this action, Defendants were aware of their obligations under Megan's Law and California's Penal Code.
- 19. Defendants knew or should have known their actions, including but not limited to the use of information regarding Mr. Ventimiglia contained on the Megan's Law Website for purposes related to benefits, privileges, or services provided by any business establishment, were illegal and in blatant disregard of Penal Code §§ 290.4 and 290.46.
- 20. As a result of the events described herein, Mr. Ventimiglia has suffered considerable damages, including but not limited to loss of income, loss of benefits, significant emotional and physical suffering, as well as pain for the affront to his dignity as a human being.
- 21. Defendants acted willfully and in reckless disregard of the law by making prohibited use of Megan's Law Website information concerning Mr. Ventimiglia, clearly violating the California Penal Code. Such conduct entitles Mr. Ventimiglia to recover compensatory, exemplary and punitive damages.

### FIRST CAUSE OF ACTION

### Violation of Penal Code §§ 290.4 and 290.46 et seq.

## [Against all Defendants]

- 22. Mr. Ventimiglia incorporates paragraphs 1 through 21, inclusive, as though set forth and alleged herein in their entirety.
- 23. The events described herein constitute a violation of Penal Code sections 290.4 and 290.46, et seq., to wit Defendants made prohibited use of information from the Megan's Law Website concerning Mr. Ventimiglia.
- 24. Defendants' prohibited use included, but is not limited to, Mr. Ventimiglia housing, employment, the benefits, privileges, or services provided by Defendants, as well as the harassment and humiliation of Mr. Ventimiglia in the community.
- 25. Defendants shall compensate all the damages they have caused, including but not limited to general damages, special damages, civil penalty, exemplary damages, and attorneys fees per statute. Damages sought pursuant to this cause of action are in addition to relief sought for the following cause(s) of action.

### SETTLEMENT AGREEMENT AND GENERAL RELEASE

This Settlement Agreement and General Release of all Claims ("Agreement") is made and entered into by and between JOSEPH D. VENTIMIGLIA ("VENTIMIGLIA") on the one hand, and ODD FELLOWS SIERRA HOMEOWNERS ASSOCIATION, and ODD FELLOWS SIERRA RECREATION ASSOCIATION, INC., its affiliates and employees (collectively "ODD FELLOWS"), on the other hand, for the purpose of settling any and all claims between them.

Whereas VENTIMIGLIA has filed an action in Tuolumne Superior Court, entitled Joseph D. Ventimiglia v. Odd Fellows Sierra Homeowners Association, a business organization form unknown, Odd Fellows Sierra Recreation Association, Inc., and Does 1 through 20, inclusive, Case No. CV55495 ("the Action") asserting various claims against ODD FELLOWS relating to his employment and to which ODD FELLOWS denies that there is any factual or legal basis for the claims;

Whereas VENTIMIGLIA and ODD FELLOWS (hereinafter collectively referred to as the "Parties") desire to avoid the expense and uncertainties associated with continuing the claims and, without admitting any wrongdoing, fault or liability of any kind, the Parties agree to settle all disputes and release all claims against each other and to enter into this Agreement.

In consideration of the mutual promises and covenants contained herein, and in consideration of other good and valuable consideration, the adequacy of which is hereby acknowledged, the Parties, and each of them, covenant and agree as follows:

**Section 1.** Consideration. In consideration for the promises made in this Agreement, ODD FELLOWS, and/or its insurers, agrees to pay VENTIMIGLIA within 30 days of ODD FELLOWS' receipt of a copy of this Agreement signed by VENTIMIGLIA and his legal counsel, the sum of TEN THOUSAND FIVE HUNDRED AND NO/100 (\$10,500.00) (the "settlement sum"). ODD FELLOWS will issue one check, less any applicable deductions, made payable to Joseph D. Ventimiglia c/o Woods & Krolikowski Attorney/Client Trust Account in settlement for full and mutual release. ODD FELLOWS will deliver the check to the Woods & Krolikowski Law Firm at 1200 Main Street, Suite H, Irvine, California 92614. ODD FELLOWS or its insurer will issue appropriate tax forms to VENTIMIGLIA and the Woods & Krolikowski Law Firm.

VENTIMIGLIA acknowledges and agrees that he shall pay all local, state and/or federal income taxes that he may be required to pay with respect to the settlement sum referenced in Section 1. VENTIMIGLIA further agrees to assume all liability for taxes and any costs, fees, interest, assessments, or penalties, due to such a determination. ODD FELLOWS makes no representations as to the taxability of the settlement sum or any portion thereof.

VENTIMIGLIA agrees that the consideration set forth above constitutes the entire consideration provided to him under this Agreement and that he shall not seek any further compensation or consideration from the Released Parties (defined below), or any of them, or from any other person and/or entity for any other claimed damages, costs or attorneys' fees in connection with the claims encompassed and released by this Agreement.

ODD FELLOWS agrees that it will not interfere with or prevent VENTIMIGLIA from advertising personal business services on or with any medium owned, operated or maintained for such purposes, by ODD FELLOWS.

**Section 2.** <u>Mutual Release of All Claims.</u> Except as set forth in this Agreement, each of the parties, on their own behalf and that of their heirs, executors, attorneys, administrators, successors, and assigns, fully and forever releases and discharges the other, their predecessors, successors, subsidiaries, affiliates, and its and theirs directors, officers, trustees, employees, attorneys, insurers and agents, whether in their individual or official capacities (hereinafter collectively referred to as the "Released Parties"), from any and all liability, claims and demands, up to the date of this Agreement, including, but not limited to, claims, demands or actions arising under any law, policies and procedures, whether formal or informal; the United States or State of California Constitutions; and *any* other federal, state or local statute, ordinance or regulation. This Release does not extend to those rights which as a matter of law cannot be waived.

**Section 3.** <u>Dismissal of Pending Actions.</u> VENTIMIGLIA agrees to take all actions necessary to dismiss the Action, with prejudice, within seven (7) calendar days of receipt of the settlement check described in Section 1, including, but not limited to, executing and filing a Request for Dismissal with Prejudice with the Superior Court.

**Section 4. Promise Not to Prosecute.** VENTIMIGLIA further agrees that he shall not, at any time hereafter, commence, maintain or prosecute any action, suit, proceeding, investigation, complaint, claim, grievance or charge with any court, administrative agency, arbitrator or any other body or person, whether Federal, State, contractual or otherwise, or aid or assist others in prosecuting such action, suit, proceeding, investigation, complaint, claim, grievance or charge on his behalf, except in response to governmental agency or court inquiries or as compelled by legal process, against any Released Party, based in whole or in part upon, or arising out of or in an way connected with, any of the claims released or any of the matters referred to in this Agreement. VENTIMIGLIA further agrees to indemnify and hold the Release Parties harmless from and against any and all claims, demands, causes of action, damages or liability of any kind, including the cost of defense and reasonable attorneys' fees arising out of or in connection with, any action, suit, proceeding, investigation, complaint, claim, grievance or charge commenced, maintained, or prosecuted by him contrary to the terms of this Agreement.

**Section 5.** <u>Unknown or Different Facts or Law.</u> VENTIMIGLIA acknowledges that he may discover facts or law different from, or in addition to, the facts or law he knows or believes to exist with respect to a Released Claim. VENTIMIGLIA agrees, nonetheless, that this Agreement and the releases contained in it shall be and remain effective in all respects notwithstanding such different or additional facts or law.

**Section 6.** California Civil Code § 1542 Waiver. VENTIMIGLIA expressly acknowledges and agrees that the releases contained in this Agreement include a waiver of all rights under Section 1542 of the California Civil Code, which provides:

- A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by his or her must have materially affected his or her settlement with the debtor.
- VENTIMIGLIA acknowledges that he has read all of this Agreement, including the above Civil Code section, and that he fully understands both the Agreement and the Civil Code section. VENTIMIGLIA expressly waives any benefits and rights granted pursuant to Civil Code § 1542.
- **Section 7.** <u>No Admissions.</u> This Agreement shall not be admissible in any proceeding as evidence of improper action by either party. ODD FELLOWS denies that there is any basis for VENTIMIGLIA's claims. No party admits any wrongdoing, fault or liability of any kind.
- **Section 8.** <u>Attorneys' Fees And Costs.</u> Except as set forth in Section 1, each party to this Agreement shall bear his/her/its own attorneys' fees and costs, if any.
- **Section 9.** <u>Waiver.</u> No provision of this Agreement may be waived unless in writing and signed by all the parties to this Agreement. Waiver of any one provision shall not constitute waiver of any other provision.
- **Section 10.** <u>Applicable Law.</u> This Agreement shall be construed and interpreted in accordance with the laws of the State of California.
- **Section 11.** Representations. Each signatory hereto warrants that s/he/it is legally and mentally competent and/or authorized to execute this Agreement and has not relied on any statements or explanations in connection therewith. Moreover, each party hereby acknowledges that s/he/it has been afforded the opportunity to be advised by legal counsel regarding the terms of this Agreement, including the release of all claims and waiver of rights.
- **Section 12.** Knowledge, Capacity And Authority. VENTIMIGLIA represents and warrants that he had the opportunity to have counsel explain the contents of this Agreement to him. VENTIMIGLIA represents that he understands the contents of this Agreement and that he executed it knowingly and voluntarily and understands that after executing it he cannot proceed against any Releasee on account of the matters referred to herein. Each party to this Agreement represents and warrants that s/he/it has the authority and capacity to execute this Agreement.
- Section 13. Confidentiality. VENTIMIGLIA expressly agrees to maintain the terms and conditions of this Agreement, including without limitation the settlement sum and the alleged bases for VENTIMIGLIA's suit, in the strictest confidence. VENTIMIGLIA may disclose the terms and conditions of this Agreement, including the settlement sum, only to his spouse or domestic partner, if any; legal counsel retained by VENTIMIGLIA; VENTIMIGLIA's personal certified accountant or financial adviser; and/or as required or compelled by legal authority. VENTIMIGLIA must notify ODD FELLOWS' legal counsel in writing within 7 days of receiving any information that he will be required or compelled by legal authority to disclose the terms and conditions of this Agreement, VENTIMIGLIA agrees that any disclosure of information made to a third party in violation of this section, whether by VENTIMIGLIA or by a person authorized to receive such information under this section, and any breach of warranties

and representations made by VENTIMIGLIA and his attorneys, representatives and agents, are deemed material breaches of this Agreement by them.

VENTIMIGLIA further agrees that if he or his attorneys, representatives, immediate family members or any other third party authorized to receive information under this section knowingly breaches this confidentiality provision, then VENTIMIGLIA agrees to pay ODD FELLOWS as a liquidated damage \$1,000 per occurrence for any breach of this Section that is proven by a preponderance of the evidence, as a reasonable estimation of the approximate damage for such breach, in addition to any injunctive relief sought by ODD FELLOWS and any reasonable attorneys' fees and costs available under the Agreement for enforcing this provision.

All parties shall respond to any inquires about the Action or this Agreement in the following manner: "The matter is over."

- **Section 14.** <u>Modification or Amendment.</u> This Agreement or any of its provisions may be modified or amended only by written agreement signed by all the Parties to this Agreement.
- **Section 15.** <u>Cooperation.</u> The parties agree to do all things necessary and appropriate to carry out and effectuate the terms and purposes of this Agreement. ODD FELLOWS agrees not to harass or discrimination against VENTIMIGLIA, including but not limited to, allowing advertising by VENTIMIGLIA consistent with Section 1, above.
- **Section 16.** <u>Interpretation; Construction.</u> The headings set forth in this Agreement are for convenience only and shall not be used in interpreting this Agreement. This Agreement has been drafted by legal counsel representing ODD FELLOWS, but VENTIMIGLIA has participated in the negotiation of its terms. VENTIMIGLIA acknowledges he has had an opportunity to review and discuss each term of this Agreement with legal counsel of his choice and, therefore, the normal rule of construction to the effect that any ambiguities are to be resolved against the drafting party shall not be employed in the interpretation of this Agreement.
- **Section 17.** Execution and Delivery. This Agreement may be executed and delivered in two or more counterparts, each of which when so executed and delivered shall be the original, but such counterparts together shall constitute but one and the same instrument. For purposes of this section, an executed facsimile copy of the Agreement may be "delivered" by one party to the other, provided that the original executed copy of the same is provided to the receiving party within 10 calendar days of said "delivery" of said executed facsimile copy.
- **Section 18.** Entire Agreement. This Agreement incorporates the entire understanding between the Parties and recites the whole consideration for the promises exchanged herein. The terms of this Agreement are contractual and not mere recitals. This Agreement may not be amended or modified in any respect whatsoever except by a writing duly executed by the Parties, and the Parties agree that they shall make no claim(s) at any time that this Agreement has been orally amended or modified.
