Therefore, IT IS RULED that:

On or before January 20, 2017 each party shall file and serve:

1. All additional documentary evidence upon which the party intends to rely in this proceeding and moves into evidence, including documentary evidence identified in the body of this ruling which is not presently part of the record of the proceeding, The additional evidence shall be identified sequentially using the above format (e.g. the first additional exhibit proposed by Complainant shall be "CV-19"; the first

- exhibit proposed by Defendant shall be "OF-1" (as identified above) and any additional exhibit proposed by Defendant shall be "OF-9"; the first additional exhibit proposed for official notice shall be "ALJ-2".
- 2. All objections to admission into evidence any of the documents identified in the body of this ruling including the propriety of taking judicial notice of ALJ-1.
- 3. A statement specifying each of the documents identified in the body of this ruling to which the party has no objection or agrees should be admitted into evidence in this proceeding.
- 4. A list of witnesses, summary of anticipated testimony from each, and time estimates for direct testimony of a party's own witnesses and for cross-examination of an opposing party's or other witnesses.

On or before January 25, 2017 each party shall file and serve:

- 1. All objections to admission into evidence any of the documents served on or before January 20, 2017 in response to this ruling.
- 2. A statement specifying each of the documents served on or before January 20, 2017 in response to this ruling to which the party has no objection or agrees should be admitted into evidence in this proceeding.
