other legal basis for OFSRA's demand for payment is that they provided work, labor or services to OFSHA at our request and then we refused to pay them for doing what we requested. They would then have a legal right to the reasonable value of the work, labor or services they provided. If OSFRA is operating under that theory, it is their burden of proof to establish the reasonable value of what they provided and show that OFSHA requested the labor or services for which they are billing. We have requested such information once and our attorney has requested it twice. There has not been any response from OFSRA. It would be irresponsible and in violation of the OFSHA Board of Director's fiduciary responsibility to the homeowners if we handed over all of the money collected to OFSRA without an accounting of why the money was required and a legal justification for doing so. We are guite willing to pay our legal obligations. The OFSHA Board has always been willing to talk to the OFSRA Board and to work with them on any problems or necessary agreements in order to be fair to both sides in these matters. After all, we are all part of the same community and should try to work things out in the spirit in which our beloved "Park" was originally founded, the spirit of Friendship, Love and Truth.



## Re: Odd Fellows Sierra Homeowners Association and Odd Fellows Sierra Recreation Association

Dear Homeowners:

We represent Odd Fellows Sierra Homeowners Association ("OFSHA"), We write to advise you of OFSHA's rights to use Odd Fellows Sierra Recreation Association's ("OFSRA") roads and water system.

OFSHA has a right to use OFSRA's water. Although OFSRA owns the water system, an October 12, 1986 Water Use Agreement states that OFSRA agrees to furnish necessary water to OFSHA. OFSRA is responsible for maintaining the water system. OFSHA is to pay \$69,350 per year to OFSRA for water. The term of the agreement is 25 years. Further, because California Department of Real Estate reports promise that lot purchasers will be provided with water, OFSHA, their representative, has a right to the water. Owners must pay the reasonable cost of the water, but OFSRA cannot charge unreasonable fees or stop them from getting water.

OFSHA also has a right to use OFSRA's roads. On October 12, 1986, OFSHA entered into an agreement for use of OFSRA's roads ("Road Agreement"). OFSRA agreed to repair and maintain all existing roads, although OFSHA is required to reimburse OFSRA for these costs. The Road Agreement's term is also 25 years. Moreover, on May 9, 1996, OFSRA recorded a declaration, which is binding on the lots, which states that OFSRA owns the roads but the lot owners have the use of them. This right is a real property interest. Therefore, OFSRA may not interfere with the owners' rights to use the roads.

OFSHA and OFSRA have agreed to extend the Water Use Agreement and License Agreement to January 12, 2012. In the meantime, OFSHA will negotiate with OFSRA and its attorneys for new agreements that will allow OFSHA, and its homeowners, to budget effectively.

OFSHA has no obligation to pay OFSRA for anything other than use of the water system and maintenance of the roads.

In the meantime, should you have any questions or concerns, please contact OFSHA. They will forward any questions that they cannot answer to us. We regret that because we represent OFSHA and not the individual homeowners, we cannot respond to your questions individually.
