Communications: From P. G. & E. giving results on voltage check on pump on Water System # 1. They stated results were very satisfactory. From Bush and Ackley regarding McKown sale. Bush and Ackley to Louis Hardie (copy) completing McKown sale.

Bills: From P. G. & E. \$24.41, \$7.70, and \$3.38 for power to Pump # 1, # 2, and Picnic Grounds, respectively: From Standard Oil Company \$52.80 for gasoline; From Newman Sheet Metal Works, \$4.95 for material for water System # 2; From Sonora Freight Lines, \$12.94 for freight on materials for Water System # 2; From Arrow Plumbing Co., \$24.43 for material on Water System # 2; From Bush and Ackley, \$618.95 for Services Aug. 1953 to Oct. 1954; From Crane Co., \$58.74 for material, Water System # 2; From P. E. O'Hair Co., \$1,167.29 for material on Water System # 2.

Motion by Hodgson seconded by Kearns that bills be paid with exemption of P. E. O'Hair and Ackley and the Secretary write them about discrepencies that appeared in them. Secretary to also write Mr. Welch about material to be picked up for credit that was left over from the installation of the Water System.

The Secretary was instructed to issue a check to Bob Nichols for \$1000.00 and interest on Bulldozer Mortgage.

It was decided to have our attorney write Oakland Lodge about the possibility of refinancing our Note and Deed of trust so that we can develop our roads at the Park.

Motion by Gibson seconded by Michols that the Secretary's salary be reduced to \$50.00 per month.

Motion by Hosmer seconded by Hodgson that the Vice Presidents salary be dispensed with.

The secretary presented a statement of cost on the water tower on Water System # 1.

No further business appearing, the meeting was adjourned.
