Motion by Excobar seconded by Spangle that request of Brother Adams to return one of his lots to the Association be granted.

A request was received by the President that his \$25.00 monthly expense account be discontinued. Motion by Excobar seconded by Wilson that the request of our President be laid over.

It was reported by the President that Oakland Lodge desired to accept the offered one-half of the recent payment by Nelson on lumber logged on our property. Motion by Gibson seconded by Escobar that we send Oakland Lodge a check for \$3,750.00 on timber sales.
