Turner approving the inspections of the cabins at the park as per letter sent out to the cabin owners, and would like to have the service extended to the time that the park opens in the spring. A letter from The Sonora Abstract and Title Co. regardigg the deed made out to Bob Smith for the sale of property from Roy Reedy in which they state that there was nothing in the records to show that there was any indebtedness against the property sold. A letter from J. Gibson Stating that he had seen brother Cakebread and asked him about the deal with the cpaper 60 gegarding the refuse timber etc at the park and that Cakebread said that he would contact the paper Co again & Brother Garrett being present at the meeting when asked about his services at the park during the winter months stated that it was his understanding that his services during the winter months were to be the same as they were last year that is two days a month . No member of the board present were of that opinion and stated that they were under the impression that Garrett was to put in full time the same as any other time, no action was taken The secretary brought up the matter of taxes on the property adjasent to the girls scout camp which was resurveyed in 1955 cutting off a portion of several lots owned by members of the park and recomended that the sugestion of the county assessor be taken into concideration to have quit claim deeds made and a map of the changes be sent to the county assessor.

It was regularly moved, Seconded and carried that the secretary see our attorney and have him make out Quit claim deeds to the property above mentioneds also to send a map of the changes to the assessor of Tuolumne County. The secretary also had tax bills paid on the property sold to Arthur Bauman and after some discussion it was moved seconded and carried that the secretary turn the tax bills over to our attorney for collection and tell our attorney to tell Bauman that we expect him to live up to the agreements he himself sugested, that is to pay one half of the money received from the timber sales etc.

P.G.&E. for Electric service at the park 11.56 Falkners Business College For mimeographing letters and cards sent to the cabin owners \$6.30 Arthur Garrett salary for November \$240.00 R.C.Rhien Salary for services as Sec.Treas. \$75.00 Tuolumne County Taxes \$845.18 Alfred Kuffel for labor on the tank cover 76.95 Arthur Garrett for Bermuda Seed to be sown on the lake banks \$2.29 Total \$1257.28 There was some discussion on the number of cards returned by the lot owners and Loren Hosmer suggested that bills be sent to those who did not return their cards as well as those that did. No furthur business appearing the meeting was closed. after which
