It was moved and seconded that the secretary have additional maps made of the subdivision. Carried. At this time nominations were in order forofficers for the ensuing year.

Nomination for president was in order and Gene Bianchi was nominated for president. It was moved that the nomination for president be closed, Seconded and carried. J.R.Hodgson was nominated for vice president. Moved and secoded that the nomination be closed. Carried R.C.Rhien was nominated for secretary, Treasurer. seconded that the nomination be closed. Carried, On ballot being taken, Gene Bianchi was elected President, J.R. Hodgson, Vice president and R.C. Rhien Secretary- Treasurer For the ensuing year. The following committies were appointed. Roads and Water- Bianchi, Nichols, And Hosmer Building committe Buck, Boydstun and Hosmer Sales, Publicity and equipment - Hodgson, Nichols, Gibson and Escoba Finance- Nichols, Hosmer and Escober. July Barbecue - Hodgson Nichols, Kearns and Escober It was suggested that the first Sunday in July Be designated as the day for the barbecue. It was moved and seconded that the Board of Directors invite Regional Council #3 to participate with us in our activities on July first. Carried A committe on program and entertainment was appointed as Follows Bianchi, Buck, Hosmer and Gibson. The secretary was instructed to write to Wm. Gagen, Commercial Manager of the Pacific Telephone & telegraph Co at Sonora about Telephone service at the park . Pay meter recommended The matter of raising the down payment on the purchaseof lots in the park was brought up and after some discussion It was moved and seconded that the down payment be set at \$100.00 payable within 60 days. Carried. The matter of the transaction of Alice Colony and Robert Booker was brought up regarding the sale of Lot 49 Block 26 to Colony fo which she holds a receipt from Booker paid in fullbut Booker refuses to give her the deed. Gene Bianchi was to confer with our attorney regarding payments due the association for water assessme ntsand association fees and feel that as long as Booker holds the deed he should be responsible for the payments. No further business appearing the meeting was closed after which refreshments were served by Mrs. Bianchi which were enjoyed by all
