Motion by Escobar seconded by Nichols that payment of 2nd Installment of County Taxes be approved.

Motion by Hodgson seconded by Spangle that we pay our attorneys \$100.00 on account.

Motion by Hosmer seconded by Hodgson that outsiders cutting wood or working for thier own benefit in the Park do so only by permit that relieves the Association of any responsibility.

Motion by Escobar seconded by Nichols that we purchase 20 gal automatic butane heater for large house from Arrow Plumbing Co.

Motion by Nichols seconded by Escobar that Brother Elmer Gray be hired to see that Picnic tables and shutoff valve on pipe be built and installed. Brother Hosmer reported Brother Gray has some 4x4 lumber he wanted to donate for the picnic tables.

Motion by Hosmer seconded by Nichols that notes be issued to members loaning money to meet payment on property.

Motion by Hosmer seconded by Hodgson that mileage to Directors for 1st quarter of 1951 be paid.

Motion by Hodgson seconded by Spangle that Hosmer take care on contacting parties to prepare and serve picnic dinner at the Annual Spring Picnic, June 3.

Motion by Escobar seconded by Hodgson that Secretary have advertising cards printed to distribute at Grand Lodge. Mention of Genes reception to be on the cards also.

Discussion of price raise on lots was held. Motion by Escobar seconded by Nichols that effective June 18, 1951 the price of all lots be raised \$50.00.

No further business appearing the meeting was adjourned.
