Elsie Manning re clarification of Cecil Walton's lot ownership - Property woned jointly with Frank Gibson.

COMMITTEE REPORTS:

Roads - Akers - Presented map of Park roads color coded showing repairs needed. Also other various work needed to gotters and culverts. Roads need approx 1100 to 1200 square feet of repairs. Motion by Gibson, sec by Dean we have Sierra Const Co do the work not to exceed \$1500.00. Passed 6-0. Lot owners please keep the gutters in front of your cabin clean of various debris - including pine needles etc. Water - Bell - Water tests are all 0 K now. Nichols Spring completely cleaned inside & out. New well tied into system and working. The State will be in to inspect again this month.
