Motion by Hosmer seconded by Hodgson that mileage to Directors be paid for second quarter of 1951.

Escobar and Loeffelbein retired at this time.

Motion by Nichols seconded by Spangle that Brother Wilson investigate two 4500 gal water tanks at Pittsburg and purchase same for \$50.00 if value is seen.

Motion by Wilson seconded by Hosmer that we license our truck.

Wilson retired at this time.

The President appointed himself to call our attorneys to plan next move in negotiating for sale of timber.

No further business appearing, the meeting was adjourned.
