Brother Spangle requested that his promissory note be redeemed and paid into the water fund. Motion by Wilson seconded by Michols that Spangles request be granted.

It was reported that Brother Al Ball wanted to trade a surveying instrument on his water assessment. Motion by Nichols seconded by Spangle that the President investigate the value of the instrument and report.

Motion by Hodgson seconded by Wilson that a moratorium be declared on payments of contracts of Brothers who may be called into the armed services of our country, for a period not to exceed 18 months.

Motion by Hodgson seconded by Nichols that we obtain a 4,000 gallon wooden tank from Brother John Hansen of Concord for the price of \$25.00.

The President appointed Brothers Nichols, Escobar, and Bianchi on a committee to plan a financial course to follow to stabilize the economics of our Association.

Brother Loeffelbein was appointed to head a planning Committee of Association Members for the 1953 season.
