MEMBERS BEFORE THE BOARD Raul Morales - Complaint against dogs running loose and causing a
danger to other members of the Park. He related the park rules and
County Ordinance against loose dogs. He recommended that if it
continues they have water shut off. He also recommended that the
fine be \$500, that water reconnection be \$750, and a second offense
be fined \$1000. He also recommended contacting the D.A. for a charge
of several violations to personal liberty.

COMMITTEE REPORTS
WATER -Smith--Water use: 585,000 gals. There will be another \$1000 next month for lead and copper testing.
ROADS -Morrison - Culvert on the property Mr. Bonette has sold. He agrees to install a culvert if it is deemed necessary. Dale will assess the situation at the next heavy rain to see what is necessary. BUILDINGS - Smith - There is still a leak in the Rec. Hall roof. Ed Smith is to get estimates for roof repairs on replacement for metal

or composition roofing.

TIMBER -Adams - The net return from timber harvest was \$16,667.84.

It was agreed by the Board that a charge of 10% of this net should be set aside for road damage caused by the hauling. This to be kept in the Timber Fund bank account, but an accounting of it kept separately.

RECREATION -No. report.

HEALTH AND SAFETY - Greene - There has been increasing use of facilities by outsiders, especially the toboggan run.

There is an increase in use of ATV's and this is still a problem.

We are concerned about our liability in these cases.
