

# Board of Directors Meeting Minutes January 10, 1999

The Board of Directors meeting was called to order at 8:30 a.m. by President Del Wallis. Those present were Del Wallis - President, Jim Morrison - Vice President, Fred Coleman - Secretary, Deena Hague, Gene Reed, Greg Brown, Robert Snell and Ron Hawke. Absent was Richard Bonner - excused. Also present was Randy Tolbert, Park Manager.

**MINUTES** - Motion by Hawke, second by Snell, to approve the minutes of the December meeting as mailed. Motion carried and so ordered.

#### **MEMBERS BEFORE THE BOARD - None.**

**CORRESPONDENCE** - County Health Department regarding natural bathing area and beach inspection program for 1999-2000. They will be inspecting our lake.

#### **COMMITTEE REPORTS**

**WATER - Morrison -** Water usage was 757,600 gallons this month. See Park Manager's report regarding broken water lines due to freezing temperatures. **Congratulations to Randy for obtaining his water certificate.** 

**ROADS - Reed -** We need a bid for road work to be done on David, Rebecca and part of Deborah. Gene to take a ride with Randy to check on road needs.

**BUILDINGS - Hawke -** Everything is okay.

**TIMBER -Coleman** Discussion about the 1999 cut and a possible fuel break in compartment four. Motion by Brown, Second by Hawke to cut compartment two and put off compartment four until we have a plan. Motion carried and so ordered.

### **RECREATION - Snell - No report.**

**HEALTH AND SAFETY - Hague** Everyone needs to stay off the lake. There have been dogs in the park off a leash. There is a leash law in Tuolumne County which the park is also subject to. Please follow the law. A car had its side-view mirror broken off by the gate while trying to run the gate. Do not try to beat the gate, use your opener.

#### **EQUIPMENT - Brown - No problems.**

**FINANCE - Bonner** (absent) - Bills this month were \$8,684.89. Motion by Hawke, Second by Hague to pay all bills. Motion carried and so ordered.

#### CARETAKERS REPORT - Randy

submitted a summary of all jobs completed and in progress this month. Because of 0° temperatures, Randy and volunteers A. Santos, L Vaughn, and D. Clark kept eyes open for frozen water pipes at cabins in the park.

Water was turned off at the water box at cabins found with broken lines. Owners need to come up and check their cabins.

**OLD BUSINESS** - Discussion by Randy about fencing dumpster and the cost (about \$400).

Discussion by Del regarding planning commission meeting for five acres. He met with the Board of Supervisors and presentations were made on behalf of the Park. Received a 75-page document of what the county wants from us. Many conditions and restrictions which they require concerning the road out to Long Barn. Had another meeting with the Supervisors two weeks later. In the supervisors' view, we won. We have serious concern of what we "won" and the related cost. Other issues/problems exist concerning the development of the five acres. Del recommends that we think about this and possibly go back to the membership in May to determine what membership wants. We need to block a couple of roads feeding into the Long Barn Road. The present gate is on County property. Motion by Reed, Second by Coleman to authorize Randy to do what is necessary in Long Barn Road area and block David and Goliath on a trial basis.

Question about license agreement concerning Roads and how to pay for repair. No action requested or taken. Question about license agreement and Board's control of roads and back country. No action requested or taken. Question concerning sign at the entrance of the park. Motion by Reed, Second by Snell to keep the new sign, with Sierra Park name and Odd Fellows insignia. Those voting yes were Wallis, Hague, Reed, Brown and Snell. Those voting no were Coleman.

**NEW BUSINESS** - Motion by Brown, Second by Hague to move the April Board of Directors Meeting to April 3, at 1:00 p.m. Motion carried and so ordered. \*Notice that this is on a Saturday at 1:00 in the afternoon, one week and one day before the regular Board of Directors meeting.

Meeting closed at 11:00 a.m.

The next meeting will be held at 8:30 a.m. on Feb. 14, 1999.
