AIR AMBULANCE MEMBERSHIP PROGRAM

Safe, expedient and life saving care is now available in Tuolumne, Calaveras and Amador counties through membership in "PHI Cares". This program provides medical transport to the nearest treatment center out of the county that meets your needs.

The flight crew includes highly trained pilots, registered emergency nurses and flight paramedics. Membership plans are as low as \$50.00 per year for a family with medical insurance. Membership does not include ground ambulance transport.

Membership application forms and brochures are available at the Mi-Wuk/Sugar Pine Fire Station in Sugar Pine on Highway 108.


HELP OUR FIRST RESPONDERS - BECOME AN AUXILIARY MEMBER

The Mi-Wuk/Sugar Pine Fire Protection District firefighters are most always the first responders to any 911 call from our Park. The Mi-Wuk/Sugar Pine Fire Protection District Auxiliary is a volunteer organization with it's primary purpose being to support the fire station and the firefighters. The District in one of Tuolumne County's "Special Districts" and receives limited funding from Tuolumne County. In order to help the District, the Auxiliary has a number of fund raising activities for raising money to help with a variety of things, such as partial payment of the station's utilities, purchase of needed uniforms, general housekeeping supplies, purchase of special equipment as needed. Some of the fund raising events include a monthly pot-luck dinner, monthly games (Bridge, Hand & Foot, Bunco and Dominoes.) In addition, there is an annual 4th of July Pancake Breakfast and an annual Spaghetti Dinner.

The Auxiliary is having a membership drive and would like to encourage all Sierra Park residents to join. There is also a special Propane Program for members through JS West Propane. General membership is \$15.00 per year for a primary family member and \$10.00 per year for each additional family member. INTERIM MINUTES

The meeting was called to order at 8:47 AM by President Harvey. Board members present: Barrett, Clark, Emery, Fialho, Harvey, Hawke, Peter, Varvayanis, and Velayas. .

INVOCATION: Given by Ron Hawke

HOMEOWNERS AND OTHERS PRESENT: Homeowner, Mike Rainwater; Caretaker, Mark Higgins

CORRESPONDENCE: President Harvey reported receiving correspondence from: Paul Emery requesting use of the Lodge on Christmas Day 2011; a thank you from Tom and Daylene Guidice for the road sign on Rebekah and for spelling the name correctly; a thank you from the Carpenter family for all the good work being done by the Board and especially how well the caretaker is doing his job; brochures and membership applications from PHI Cares, an air ambulance service.

MINUTES OF BOARD MEETINGS of December 14, 2010: Emery moved that the minutes be accepted as presented, Peter seconded, motion carried.

DIRECTOR REPORTS:

WATER-HAWKE: Homeowners are strongly encouraged to turn off their water supply valves and drain their cabins whenever they are going to be away during the cold winter months. The pipes to the well houses have not yet dropped below 45 degrees F, even while the interior of the well housed has dropped to 31 degrees F. There were no water leaks during the month. The water usage for the month of December was 758,400 gallons. An annual membership renewal invoice for California Rural Water Association has been received in the amount of \$356.00. This organization represents small water companies and provides opportunities for free training for members.

ROADS-EMERY: Noted that crack sealing will have to be done again and that this is an annual procedure. He will be getting bids for this work.

BUILDINGS-BARRETT: Deferred to Peter. Peter reported that the permit for the installation of the wood burning stove for the caretaker's cabin has been received and the stove will be installed next week.

EQUIPMENT-PETER: There were several issues with the snow plow truck and the Case backhoe during the month that required repairs. Equipment is now running fine.

TIMBER - VARVAYANIS: No report

HEALTH AND SAFETY-FIALHO: No report

GATE-VARVAYANIS: There was an issue at the gate that involved some mischief from young people blocking the entrance with a snow block wall. The sheriff was called. There was no damage to any Park property. After discussion, it was determined that no further action should be taken at this time. There are defects with the surveillance system. The cameras need to be adjusted. After discussion, it was determined that members of the Board will get together to do the adjustments. The magnetic locks need to be replaced. The cost will be approximately \$2000.00 including hardware and shipping costs. This is within the budget for the gate. Varvayanis will order locks and parts. He will get bids for installation.

FINANCE-VELAYAS: Preparation for the 2011/2012 Budget is in process for the March deadline. Work is also in progress regarding policies and procedures for delinquent accounts. Bills presented for payment are \$12,146.10. **Hawke** moved to approve payment, **Barrett** seconded. Motion carried. Discussion regarding the repayment of funds to the Timber Fund, the Water Reserve Fund and to the Road Reserve Fund. These items will be addressed in the Budgeting Process.

COMMITTEE REPORTS:

WATER LICENSE – VARVAYANIS: Director Varvayanis reported that the committee has been working for 9 months on the License Agreement and the Water Use Agreement... The present agreements expire in October 2011. The revisions need to be brought before the general membership at the annual meeting in May 2011. He stated the changes to the Water Use Agreement are mostly for clarity and to clear ambiguities. The duration of the agreement changed from 25 years to 10 years. The committee needs approval from the Board to allow the attorney to review further for corrections to verbiage and to reformat as they tie into the rules and regulations of the associations. There are some fees and fines associated with the agreements and need to be voted on by the memberships. A schedule of those fees and fines needs to be established. The CC&Rs need to be addressed. A legal description is needed to describe the actual physical boundaries of the property that the agreements encompass. For the effectiveness of these license agreements, two separate Boards of Directors need to be re-established. It is possible that an amendment to the by-laws may be needed for clarity of the relationship of the two corporations. After discussion, it was

determined that the committee should continue with their revisions, clarify who should sign the two documents and contact the attorney for further guidance with regard to the revisions to the agreements, a possible change to the bylaws, and the re-establishment of two Boards of Directors for the two associations.

UNFINISHED BUSINESS:

- 1. Raft Emery reported that he and Peter will be working on getting the raft ready for this summer.
- **2. Lights President Harvey** reported that an assessment of the lights in the Park will be made to determine if some may be put on sensors and others on timers. An electrician will be contacted to do this assessment.

NEW BUSINESS:

- 1. Acceptance of the resignation of Director Clark. Fialho moved to accept, Peter seconded. Motion carried.
- **2. Appointment of interim Board Member.** As there were no runners up at the annual meeting in May 2010, President Harvey stated that Mike Rainwater applied for the vacancy. After discussion, **Hawke** moved, **Peter** seconded that Mike Rainwater be appointed to the vacant position of Secretary to serve the balance of the year. Motion carried.
- 3. Proposal from Rebekah Dogwood Lodge #200 President Harvey read a request from the Rebekahs to have the Lodge Hall cleaned and painted. They are requesting the OFSRA pay 50% of the cost. They received three bids for the job. Aloha Painting has given them the lowest bid of \$3200 to do the work. The rafters and ceiling will be thoroughly cleaned. The bathrooms, Board room and Hall will be repainted, including the doors. After discussion, Hawke moved to accept their proposal, Emery seconded. Motion carried. In addition, the Rebekahs want to clean up the kitchen area and replace worn out equipment. They would also like to buy new, light weight tables for the Lodge Hall at their expense. Hawke moved to accept the Rebekahs offer. Peter seconded. Motion carried. Velayas moved that the Rebekahs be given permission to dispose of the old tables as they see fit. Hawke seconded. Motion carried.

ADJOURNED TO EXECUTIVE SESSION AT 10:37 AM EXECUTIVE SESSION CALLED TO ORDER AT 10:38 AM ADJOURNED EXECUTIVE SESSION 11:13 AM OPEN REGULAR SESSION 11:14 AM

PRESIDENT HARVEY ANNOUNCED no action was taken during the executive session.

OTHER BUSINESS:

Director Hawke moved that caretaker Higgins be allowed to attend a Davidson class on March 7th and 8th, **Varvayanis** seconded. Motion carried.

President Harvey announced she has contacted the Cover family to prune the apple trees so that better yields will be possible in the future.

There being no further business, the meeting was adjourned at 11:15 AM
