The Board of Directors' meeting was called to order at 9:00 AM by President Bert Johnson. All members were present.

MINUTES - September 7, 1986 B.O.D. meeting were read and approved.

CARETAKER'S REPORT - Water system maintenance, garbage cleanup, equipment repair, road maintenance, replaced culvert, winterized campground, repaired foot bridge and cleaned culverts.

## COMMUNICATIONS:

Michael Klapp - Expressing concern over the closing of the campground on January 1, 1987 for over-night camping and recommending alternate solutions. After much discussion it was decided to let the "closing decision" stand and allow the decision to be discussed at the annual meeting in May.

Capps, Staples, Ward, Hasting & Dodson - Notifying B.O.D. of appearance in Superior Court for the purpose of setting a trial date and settlement conference date for the Jones vs. Linthicum, Goff, and Odd Fellows. No action is required.

## COMMITTEE REPORTS

WATER - Johnson - Recording meter is not connected to the new well, so usage readings are approximate. Usage for the month is estimated at 975,000 gal. Tests for the new well indicate it meets health standards and it is now connected to the water system.

ROADS - Hintz - Patching is complete and culverts/bar ditches are being cleaned. Motion by Wallis, sec. by Pernetti to purchase 10 yds of black sand for winter use. Passed.

BUILDINGS - Mitchell - The lake will be lowered to the bottom of the overflow.

**HEALTH AND SAFETY** - Smith - Garbage abuse continues to be a problem.  
**RECREATION** - Boff - Campgrounds receipts for September was \$10.00.

Motion by Hintz, sec. by Armstrong to authorize Bert Johnson to sign the water use agreement on behalf of Odd Fellows Sierra Recreation Association for a sum of \$69,350.00 Passed. Motion by Pernetti, sec. by Mitchell to authorize Bert Johnson to sign the License Agreement on behalf of the Odd Fellows Sierra Recreation Association. Passed.

## TIMBER MANAGEMENT - Wallis - Noni

FINANCE - Cole - Bills in the amount of \$6054.50 were presented. Motion by Pernetti, sec. by Goff to pay the bills. Passed. Income for the month was \$8,574.89. There are 27 plus members who have not paid their dues, for a total amount of \$6,700.00 plus. Motion by Cole, sec. by Hintz to disconnect water service on Nov. 1, 1986 to lots where delinquent balances remain. Passed. A reconnection fee of \$25.00 plus a \$5.00 administrative fee will be charged for reconNECTIONS.
