**LAKE NEWS**

We discussed an open fishing day for this year before we drain the lake. A date has not been set and we want to get this newsletter out immediately, so watch the sign by the Rec. Hall for the only date fishing will be allowed for all homeowners. (Fishing license required for everyone over 16 yr. of age.) While writing about the lake, we have been made aware of the erosion of the creek banks on the west side of the lake. This erosion is starting to cause damage to the levee at that end and it is in potential danger of collapsing. The creek is also getting deeper banks that could be a danger if someone fell into it. We are getting some information about resolving the problems but they aren't cheap—is anything anymore? The lake still needs to be dredged. This is a project the board has been trying to accomplish for 4 or 5 years. The cost of that has risen many times over the last estimate.

We had Patrick Adams give a presentation on his recommendation to take care of these problems. The cost \$84,000 total. No action will be taken at this time but if anyone has expertise in this area we would appreciate your input and help. Unfortunately, we cannot ignore the need to maintain the infrastructure of the great amenities in our park. If we do, we could eventually lose them.

**Roads, Bar ditches & Culverts**

The scheduled paving in the park was completed and the bar ditches have been cleaned. The roadways look so much better. The latest project, in preparing for winter, was completed by Mike C. with the help of Mike Rainey. They cleaned the culverts around the park. About a 1/2 dozen culverts are damaged & cannot be cleaned. The homeowners must repair them. *Letters will be sent to homeowners who must take action.*

The meeting was called to order by President Mike Rainwater at 8:45 a.m.

Members before the board: Serge Peluso, Doris Kilgore and Maynard Wallin.  
Minutes of September meeting were approved as mailed. (Motion Townsend/Aston)  
Correspondence: Letter from Roger Brown, atty., concerning BSA lawsuit. Still pending  
Letters from Caldwell Insurance, policies and changes on policies.

Committee Reports:

**WATER – Bob Cloak**—Water usage was 805,000 gals. Ross Porter of Cal/Porter, inspected the interior of the water storage tanks. All 6 tanks are in good safe condition. May need some coating in 5 – 6 years. He has had a couple of complaints of taste of chlorine in water, but tests show very low safe levels.

**ROADS – Charles Varvayanis** - Roads in good shape, the cost of paving seemed more than what was expected. The contract will be reviewed. The bar ditches have been cleaned by an outside crew of 5 to 7 men. This allowed the work to be done in 6 ½ days. The cost was approximately \$4200. Mike C. is cleaning the culverts with the help of Mike Rainey.

**BUILDINGS – Clark** everything okay.

**TIMBER – Townsend** - Paper work for the state will be completed as required by the state.

**HEALTH & SAFETY-Aston** – 12 new speed signs for the park have been received. All say 20 MPH.

Mike C. and Mike Rainey are purging the fire hydrants as they clean the culverts. Culverts that can not be cleaned because they are damaged must be replaced or repaired by the homeowner. They will be notified by letter.

Discussed time to drain the lake and Charles will verify when the fire season might be declared closed. The lake can be used for fire safety until such time. After fire season and before we drain the lake, a special homeowners fish day will be scheduled and posted on the info sign by the rec hall.

**EQUIPMENT – Van Gundy** - Ordered seat covers and floor mats for the park pick-up. Also, located and purchased chains for the snow plow. He will have them shipped from Sacramento.

**RECREATION – Clark** Board confirmed the date for the Holiday dinner as December 17<sup>th</sup>.

One set of swings and the slide have been sold. We still have the merry-go-round and another set of swings.

**FINANCE – Selman** – 10 homeowners have not paid their assessment. A late fee of \$25.00 each month is being added to the original assessment. A list of the homeowners who have not paid their dues will be listed in next month's newsletter. They are subject to water being turned off and small claim court fees, plus liens on their property if not paid. Discussion of bill payment procedures determined the need for check writing ability at the park when the new computer is up and running. A method will be put in place.

Motion to pay bills (Varvayanis/Aston) unanimous. The total amount approved, \$47,157.93 included payroll already issued. The newsletter will print the check ledger as it has each month to insure the homeowners see the monthly expenses.

**OLD BUSINESS** – Generator purchase continues to be pursued. Mike Van Gundy will also help with this project. Since Katrina & Rita hit the Gulf Coast, generators are in short supply and new orders are delayed 4 to 8 months. Charles reported the new computer should be installed next week. He found a free laser printer that should give us good quality copies as long or longer than a new ink jet model.

**NEW BUSINESS** – Mike C. has asked for the door of the sand shed to be repaired or replaced before the snow season and if possible an opener installed. Roger and/or Tom will take care of the problem.

Patrick Adams was introduced and gave a presentation regarding the dredging and repair of creek bed to protect the north levee of the lake. Cost \$84,000. He was asked to make up a written presentation for us to consider at a later date.

Mike Rainwater handed two letters to Doris (officer in attendance). She read the brief resignations from Mike and Bob Cloak. The board accepted with regret and thanked them for their many hours contributing to the welfare of the park. This was a personal decision and not discussed.

Board adjourned to Executive session at 1:50 p. m.

Adjourned executive session and returned to regular meeting at 2:10p.m.

Having been elected President of the board in executive session, Roger Townsend presided over closing discussion and scheduled a special board meeting for Oct. 22, 2005 at 9 a.m. Meeting was adjourned at 2:15 p.m.

Next Board meeting will be November 17, 2005 at 8:30a.m.
