WINTER MAY BE LONG AND HARD-If you plan to come to the Park from now untill late Spring, be sure to carry chains and be sure they fit your wheels. Also be sure you know how to put them on and off. All roads up here are subject to chain control, and to go beyond a chain control sign will bring a big fine. Our road going out of the park sometimes is very icy and even without chain control you need them to get the traction to get out safely. Be sure your battery and tuneup on your vehicle is in tip top shape, cold zero weather puts a mighty strain on these things. Be sure to have flashlights and alternate lighting around your cabin as power outages are common during the winter, sometimes many hours long. Do not park on roads, plan on clearing a space clear of the roadway or plan on parking either in the lots by the Recreation hall or by the lake. If you get stuck or break down in the park be sure to have road insurance as park equipment is not allowed by the park's insurance liability to tow or push even members vehicles.
