The monthly bills amounted to \$9,321.55. OLD BUSINESS - Caretaker will be reimbursed for insurance allocation that was promised him when hired. This amounts to \$115 monthly in lieu of medical insurance that he already had.

NEW BUSINESS - The firetruck is not being operated due to the fact that we now have only two volunteers. This is not sufficient number for the park to keep the new truck. The old truck will be returned and we are still being covered by Mi Wuk and Long Barn fire depts. All equipment that we purchased and put on the new truck will be removed and kept for our use. Motion by Hintz and 2nd by Goff to authorize Bert Johnson to negotiate with the county for change of fire equipment. Motion passed. The blade for the snow clean up was discussed. No action taken.

We have 16 delinquent members for non payment of assessments due. Papers will be put through process of small claims court. After judgement is handed down members will be given 10 days to pay or water to cabin will be shut off and there will be a \$25.00 hook up fee levied for rehook up. Motion made by Hintz and 2nd by Goff to proceed with the above. Motion passed. Monthly interest charge of 1.5% per month will also be charged.
