

PARK NOTES

A BIG THANK YOU to Ann Coleman for picking up all the litter around the park while she's out walking. She is certainly doing more than her share to keep the park looking nice. It's too bad there is any litter out there for her to pick up. Please don't litter -- especially don't throw cigarette butts along the roads. In the dry times of the year, they will be a real fire hazard.

There were several cabins with broken water pipes during the past month. Maybe the owner's insurance helped pay for the damages, and maybe not. But, there's no way to pay for the priceless wasted water. So, here's a repeat of some previous information:

WINTERIZE YOUR CABINS WHEN YOU LEAVE.

Turn off the valve on the main water line coming into your cabin, drain the lines, open all of the faucets, pour some antifreeze (like you use in your car radiator) down every drain and in the toilet. If you don't want to do this, you'd better check with your insurance company to see if you are covered for water damage if you pipe freeze and break. Some insurance companies don't cover this kind of damage, so all of the repairs will be out of your pocket.

It seems early to start thinking about raking pine needles, but is won't be long before that time is here. The Forest Service has greatly increased the fines for not raking the needles and clearing slash at least 30 feet from your cabin. First time offenders will be fined \$270. Second time offenders (within 5 years) will have a mandatory court appearance and a minimum fine of \$570 and a maximum of \$1,500. Third time offenders will have committed a misdemeanor and will be prosecuted by the District Attorney's Office. The minimum fine is \$1,500 and the maximum is 6 months in jail. Last year they issued 65 citations within the Tuolumne/Calaveras Ranger Unit. One person was turned over to the D.A.'s Office and there is a warrant out for his arrest. So, they are really serious about getting our lots cleaned and doing everything we can to prevent fires.

Board of Directors Meeting, February 16, 2002

The Board of Directors meeting was called to order at 8:30 a.m. by President Del Wallis.

Present were: President Del Wallis, Secretary Norrine Coyle, Treasurer Richard Bonner, Members Raul Morales and Ed Smith. Absent were Vice President Robert Snell, Members Greg Brown, Fred Coleman and Deena Hague, excused.

The invocation was given by Richard Bonner.

By motion (Smith/Morales, unan.) the minutes of the January meeting were approved.

Correspondence: Letter from Jan Opland requesting use of the park and barbeque facilities on July 10, 2002, for a family reunion; letter from Attorney Roger Brown concerning a "Quiet Title Complaint" on the Soares property; letters from the State Dept. of Health Services with its "Annual Report to Drinking Water Field Operations"; and from the California Regional Water Quality Control Board re. MTBC discharges.

Committee Reports:

Water - Morales: We used 294,700 gallons of water the past month. There were leaks in several cabins. The Park Manager turned the water off at the main box at these places.

Roads - Snell: The roads were plowed and sanded.

Buildings - Smith: The Park Manager contacted Barton Overhead Doors about the insulation, and Barton was unable to find their copy of the estimate given to the Park, and will hunt for it. A cover is needed for the backhoe similar to the one over the garbage dumpster.

Timber - Coleman: Will Dorrell said he had looked at Compartment #5 and there is a lot of timber in it. He will get bids for doing the logging. The lake will be raked again, and he will look at it later and see whether or not the tules need to be sprayed again.

Health & Safety - Hague: There were two instances where Park members or renters have been "4-wheeling" in some of the open areas. They were charged for the cost of repairing the damages. Driving vehicles in the meadows and open areas will not be tolerated.

Equipment - Brown: Repairs were made to the truck.

Recreation - Snell/Coyle: The annual St. Patrick's Day dinner was set for Saturday, March 16; the annual Fish Derby will be on Saturday, June 15; because of the Fish Derby, the Board meeting for June will be on Sunday, June 16. Since we no longer have access to Fish Derby prizes from Longs, the Board would appreciate it if anyone who has access to prizes would let any of the members know, and monetary donations for purchasing prizes would also be appreciated.

Finance - Bonner: The bills for the month were \$11,116.98 plus \$3,031 for timber taxes. By motion (Morales/Bonner, unan.) the bills were approved for payment.

Old Business: Regarding the Soares property on which we have foreclosed, the Attorney has filed with the State. The State may tell us this matter needs to go to Federal Court. By motion (Bonner/Morales, unan.) the Boy Scouts will be told to enter their property through the upper road. We will plow the area this year but after this, we will charge them for plowing. They will also be reminded that we have given them the right to use the roads and that they do not have a proscriptive right to the use of our roads.

New Business: By motion (Smith/Morales, unan.) Jan Opland's request to use the park on July 10, 2002, was approved.

There being no further business, the meeting adjourned at 9:55 a.m. The next meeting will be on Saturday, March 16, 2002, at 8:30 a.m.
