The Board of Directors meeting was called to order at 9:00 AM by President Bob Hintz. All members were present.

MINUTES -Minutes of January 8, 1989 and February 12, 1989 B.O.D. meeting were read and approved.

CARETAKERS REPORT General maintenance -Water system maintenance -road repair - equipment repair - garbage clean up. John Henry is resigning effective May 31, 1989. B.O.D. commends him for 4 years of good work.

CORRESPONDENCE: - Letter from Bobbie Brink resigning from the B.O.D. due to personal matters. Our sincere thanks for her time and work. From Tuolumne County Fire Department asking information on water system for insurance rating.

From D. Girling reporting finishing our new road map with addresses. From Fidelity National Title concerning sale of Lot 83, Block 4 from Cliff Opland to Fred and Barbara Coleman. Referred to bookkeeper.

From I.O.O.F. Lodge #42 concerning the membership of Dale Austin.

From Santa Clara Land Title Company regarding change of ownership of lot 60 block 5 (Keith Adamson to Leo Amaro). Referred to bookkeeper.

MEMBERS BEFORE THE BOARD - Bob Baker regarding the block wall built on park property. He will present permits from the County, plot plans and engineers report for Board approval.

COMMITTEE REPORTS WATER -Pernetti/Johnson - 2,166,500 gallons used. Bacteria reports are all negative.

ROADS - Bradley - The winter has taken its toll on our roads. Much road work will be required this summer.

TIMBER -Smith - Will contact Tim Tate on taking out dead trees on park property.

BUILDINGS -Mitchell - The snow damage to the sun screens at the lake will be repaired as soon as equipment can get in.

HEALTH AND SAFETY -Garner -Signs have been placed on fuel tanks.

EQUIPMENT -Armstrong - Many repairs have been made to snow removal equipment.

FINANCE -Zobel - M/S/C to transfer \$2,705.44 from Homeowners account to Recreation account. Balance in checking \$1,700.79; Balance in Homeowners \$3,105.44; Balance in Timber checking \$1,711.60. Bills in the amount of \$5,168.15 for Recreation Association and \$93.25 for the Homeowners Association were presented. Income was \$735.61. MSC to pay all bills.

OLD BUSINESS - D. Girling presented the new map that will be located outside the caretakers cabin. Our sincere thanks to Dorothy for her beautiful work. The map shows all streets and house numbers.

NEW BUSINESS - A discussion was held on replacing the caretaker. A discussion was held on costs of replacing snow removal equipment, park property repairs, upgrading and repairing roads, insurance costs for park, etc. Board members were assigned to investigate replacement costs, etc.
