

#### Board of Directors Meeting Minutes April 9, 2000

The Board of Directors meeting was called to order at 8:30 a.m. by President Del Wallis. Those present were President Del Wallis, Treasurer Richard Bonner, and members Ron Hawke, Deena Hague, and Raul Morales. Absent and excused were Secretary, Norrine Coyle and Fred Coleman. Absent and unexcused were Greg Brown and Robert Snell.

The Invocation was given by Richard Bonner.

MINUTES - By motion (Bonner/Hawke, unan.), minutes of the March 12, 2000 meeting were approved as mailed.

#### MEMBERS BEFORE THE BOARD - None.

CORRESPONDENCE - Letters from Jim Morrison; from Acordia Insurance - re: rating basis for workman's comp insurance; from Board of Equalization - important changes in Timver yield tax reporting requirements; Notice of Proposition 65 settlement regarding water meters leaching lead into the water, Our park has none of these meters.

#### **|COMMITTEE REPORTS**

**WATER** - Randy reported that 690,300 gallons were used during March.

ROADS - Snell - (absent) No report.

BUILDINGS - Hawke - No report.

HEALTH AND SAFETY - Hague - Motion by (Hague/Hawke, unan.) To remove dead trees on Rebekah, cost not to exceed \$500. Motion by (Bonner/Morales, unan.) Vaughn to remove tree on his property - he keeps the wood.

#### RECREATION - Coyle/Snell - No report.

**FINANCE - Bonner -** Bills for the month totaled \$8,289.21 - By motion (Morales/Hawke, unan.) The bills were approved for payment.

**TIMBER** -Coleman - Motion by (Hawke/Hague,unan.) Agree to harvest in comparyment 4 according to logging plan presented by our Forester, Will Dorrell. Also, approvef application of algae reduction program at the lake.

**EQUIPMENT** - Brown (absent) - No report.

**CARETAKER'S REPORT -** Randy reported on the dead trees in the Park that need attention. The detailed report is attached to the original copy of the minutes.

OLD BUSINESS - Del addressed communication re: Canales property dispute. Motion by (Hague/Morales, unan.) Refer matter to attorney Larry Haun to proceed with legal action against Canales' on encroachment issue on Park property. Gellatly - Legal action taken allowing a time frame for appeal action. Hoffner - Attempted to serve - delay pursuit of private investigator.

**NEW BUSINESS** - A letter of resignation was received from Jim Morrion stating priority changes in his life. The resignation was regretfully accepted with thanks to Jim for a job well done. Raul Morales was called upon to fill the remainder of Jim's term in accordance with the by-laws.

Motion by (Morales/Hawke, unan.) For Randy to build bins to hold gravel and sand behind Rec. Hall area. Material from the old log cabin kit will be used for this purpose.

Motion by (Bonner/Morales, unan.) To trade some gravel for redwood decking. To **REEMPHASIZE**: Issuance of temporaary entry codes will be limited to special circumstances. Property owners will be responsible for providing entry for their personal contractors. Please advise contractors to be sensitive about litter.

Morales was appointed by Wallis to chair the water committee.

The Meeting was adjourned at 10:35 a.m. The next meeting will be May 14, 2000, at 8:30 a.m.
