We had a foot of snow on April 8 and there is more in the forecast for later this week. So be prerpared to winterize your cabins before you return home. We would suggest you expect to do so until the end of May.

You may have noticed that the lake has not been refilled yet. Some may have been disappointed that it was not ready for Easter vacation. The forester treated the tullees last fall and that left a lot of debris that needed to be taken care of when weather permitted. That clean-up is in progress. We are sure you will appreciate that we will have a clean lake to enjoy when all work is complete.

It is time again to rake pine needles and get our lots cleaned up to meet Forrest Service standards. The



burn area is open and your needles and any branches that may have fallen this winter should be taken there for burning by the caretakers. These are the only materials allowed in the burn

area because of air quality control. All lots should be cleaned up by the end of May.

Randy and Mike along with some volunteers are busy cleaning up, taking care of a couple of water leaks on park property, notifying property owners of water leaks and sprucing up the park. Mother Nature deposited quite a few broken branches throughout the park during the winter storms. Some of them were pretty good sized ones and some did some property damage.

Board of Directors Meeting Minutes April 15, 2001

The Board of Directors meeting was called to order at 8:30 A.M. With prayer by Richard Bonner. Present were Del Wallis, President, Robert Snell, Vice President, Richard Bonner, Treasurer, Deena Hague, Fred Coleman, Greg Brown, Raul Morales. Those absent Norrine Coyle and Ed Smith excused.

MINUTES - The minutes of the March meeting were approved. Motion by Deena Hague, second by Robert Snell.

CORRESPONDENCE -

- 1. George Reed Inc., Bid for 2001 road work.
 - A. Repave Ruth, Ester, Rebekah and on David from Rebekah to Wheeler Rd., \$22,400.

 - A. Refund on vehicle tax.
 - B. Refund of \$3,472.00, part of State contribution for our forest management plan.
- 3. Non-renewal of our Worker's Compensation from our carrier HIH Insurance company. Our agent is in the process of finding us a new carrier and our insurance will continue.

 - A. Our water system is covered under our \$3,000,000. General liability limit.
 - B. Our water tanks are not covered under our property damage insurance. Cost to cover would be \$1.00 per \$100.00 of value.
- 6. Information from County about meetings on Williamson Act.
- 7. Letter from Sue and Fred Padgett informing us of the sale of their property and thanking the Park employees and Board for such a nice place, well maintained.
- 8. Confirmation from Galen Hayes Insurance, that Mark Patton of Tamarack Tree Service is covered with liability insurance.
- 9. County bank Information about a Time Depost.
- 10. Forest Service Fuel hazard reduction in South Fork of Stanislaus and Five mile creek watersheds. One part of plan is a controlled burn.
- 11. Information about water system operators.

COMMITTEE REPORTS

WATER - Morales: 830,700 gallons this last month. High usage due in part to breaks. Park line on Jordan East broke. Cabin owner on Jordan East had break in one inch line and about

20,000 gallons a day lost. Problem with working on leaks when hole dug is fills up with water. Need a gas driven sump pump to keep water out to make repairs. Randy to check on cost and report at next meeting.

ROADS - Snell: Reed to oil roads in May and Overlay and repairs in July. Motion by Brown and Coleman to approve bid by Reed for 2001 road work plus the addition of a speed dip on Wheeler Rd. Not to exceed a total of \$46,000.00 for all wor BUILDINGS - Smith: Nothing reported.

HEALTH AND SAFTEY- Hague: We have a weed problem in the lake. Too thick and a danger to the children when they swim. Motion to have California Reforrestation Inc. [our reforrest advisors] to work with Randy and Mike in cleaning out these plants. Motion by Bonner and Morales to do work. Small dock at lake being rebuilt. Sun shade being redone and at the same time new cover over garbage area. With lake drained we found the bottom drain and we will make sure it works properly before refilling. With warmer weather approaching there are more people out walking and children out playing. Watch your speed in the Park. 20 miles per hour max., tell your family and guests. There is a bear and cub in the Park. Keep pet food and garbage contained. They are attracted by these items.

TIMBER - Coleman: Our forester estimates an income for us of \$70,000.00 from the timber cut this year. We have been approved by the State for a cost sharing grant to do work in our forest. We pay about 1/4 and the State pays the rest. It is part of our forest management plan. The timber harvest will be in May or June.

RECREATION - Snell: Getting ready for fishing derby. Need permit, will be geting plenty of fish. There will be prizes this year. Need volunteers to help write down and keep track of who catches what.

FINANCE- Bonner: Bills \$9,567.89 this month. Motion Snell, second Morales to pay bills, carried and so ordered. Money to be moved (\$11,000.00 approx.) From Timber Fund for estimated timber tax. Budget- we are asking for an increase in assessments of \$23.00 for a total of \$450.00 per year. We have some unknowns, fuel and power increases. Motion by Coleman and second by Brown to send budget to membership for their consideration. Carried and so ordered.

OLD BUSINESS - Bonner, Morales and Coleman, all to run for re-election. Nominations will be taken from the floor. Anyone wanting to run needs to notify the Board by mail by the next meeting so that their names will appear in the May minutes and mailing.

NEW BUSINESS- Randy will need a water distribution license and will work with Raul Morales on this.

Next meeting- May 13, 2001 Meeting closed at 9:40 A.M.
