PINE NEEDLE CLEAN UP TIME: It is time to clean your lots of pine needles as this year is going to be dry like last year. The burn area is open in the meadow so take your needles there to be burned. The Forestry has their signs up that inspection of lots will begin May 1, 1988. This is a requirement of the forestry as we live in the National Forest here in Odd Fellows Park.

LONG BARN VOLUNTEER FIRE DEPARTMENT - As you know we no longer have a volunteer fire department here in Odd Fellows Park, so we are dependent on the Long Barn Department for our help in case of fire. Here is an excerpt from their newsletter:

"We, the members of Long Barn Fire Department and Auxiliary members, wish to thank you that have donated to see that we have the equipment and gear for our firefighters. Without you, it wouldn't be possible. For those of you that have not yet sent in your tax-deductible donation, we hope you will. Even though the rains did come, the water situation is still critical and the fire danger is very high. The extreme fire danger this year has been doubled by the lack of water supplies in Tuolumne County. The Forestry Department will be inspecting all the properties in our area and are issuing a citation to any house that is not cleared back 30 feet from any structure. You will be sent a notice and if the area is not cleaned you will be subject to court action."

FIRE EXTINGUISHER SERVICE - Mother Lode equipment fire extinguishers will have a service man available to update, service or replace your home fire extinguishers from 10 AM to 4 PM at the fire house in Long Barn on May 28, 1988. The fee will be \$7.50 in most cases. New extinguishers will be available for sale."

BOARD OF DIRECTORS MEETING - MAY 8, 1988

The Board of Directors meeting was called to order at 9:00 AM by President Bert Johnson. All members were present except Mitchell, excused.

MINUTES -Minutes of April 10, 1988 B.O.D. meeting were read and approved.

CARETAKERS REPORT - Trenches were dug for electrical between wells, general maintenance on equipment, cleaned culverts, checked and serviced water lines, etc.

CORRESPONDENCE: Mabel Morris - Submitted deposit for the rental of the Recreation Hall on June 25, 1988. Referred to Garner for action. Jan Gellatly - Notifying the B.O.D. that Isla Gellatly would appear at the next B.O.D. meeting if his work schedule would permit. See Old Business for action.

Alden Moody - Notifying the B.O.D. of the dates of his degrees. This was referred to the bookkeeper for inclusion in our records.

Planning Department, County of Tuolumne - Requesting comments on proposed structure for Camp Cedarbrook. Johnson has written a negative report back to the County because it may cause problems with our "Spring" water supply, cause additional dust to our members, etc. No further action is required at this time.

MEMBERS BEFORE THE BOARD - None.

COMMITTEE REPORTS WATER -Johnson - Water usage for the month was 2,812,100 gallons.

ROADS -Hintz -Cleaned culverts and ditches.

BUILDING -Mitchell -No report.

HEALTH AND SAFETY -Smith - Outside latrines are in place for summer use. The park is not being charged for latrines until June.

DOGS ARE NOT ALLOWED IN THE LAKE AREA.

RECREATION -Garner - The recreation Hall is being painted. SEE SPECIAL NOTE IN PARK NEWS ON THIS!!

TIMBER MANAGEMENT -Wallis - Bug infested trees are being harvested in three selected areas.

EQUIPMENT - Pernetti - Routine Maintenance was performed.

FINANCE -Cole -Bills in the amount of \$12,307.56 were received.

Motion by Smith, sec. by Hintz to pay the bills. Passed.

OLD BUSINESS - Pernetti and Smith reported a review of the Bellatly property where a downed tree was an issue indicated the tree was on park property. The tree will not be replaced. No further action is required.

NEW BUSINESS - The 1988 Annual Meeting will be held May 29, 1988 at 9:00 AM in the recreation hall. Please plan to attend. There are three director vacancies coming due at the annual meeting. Bobbie Brink and William Zobel have expressed interest in running for the B.O.D. Their names as well as others that are interested will be mentioned in future minutes and on the proxy statement. Turn in your names to a director or mail an interest statement to P.O. Box 116, Long Barn, CA 95335. Nominations will be received "from the floor" at the annual meeting.

We have enclosed a proxy (on the reverse of this) for your convenience. Whether you have the Board exercise your proxy or you choose someone else to act as agent isn't important to the Board. What is important is your right to execute a vote. All written proxies must be filed with the Secretary prior to the 1988 Annual Meeting and reviewed by the inspectors of the election for authenticity and validity.

Members who execute a proxy and later decide to attend the meeting can rescind their written proxy by voting in person. If you are in doubt, please complete the proxy statement and authorize someone to vote on your behalf.
