The budget was submitted as designed and approved by the Board of Directors, but the reserves reflected an \$80,000.00 shortfall. When we discovered the error, it was too late and we resigned ourselves to receiving a lot of cards and letters from the membership. To our surprise, we have had zero response, which to us means you aren't reading your mail or you trust that we just made an error. Actually, we prefer to correct the error and blame it on the computer. Everyone remains happy, except maybe the computer and if it objects too much, we will just unplug it.

You will see in this month's minutes that we have



adjusted some salaries. This is the second adjustment in the past three months. It is our intent to have competitive salaries and continue to bring more of the work we contract out

performed by our own employees. We have better control of our costs and the quality of work. The salaries include wages and benefits. We couldn't completely settle our salary treatment for our people until this week because we needed the government to offer up a medical package. This has been done and salaries (benefits included) have been set.

Our budget anticipates the same assessment for this next year as last. It will be a busy year with many improvements. We need to continue replacing water valves (too many areas of the park can not have the water shut off for maintenance), roads need to be paved, etc. The Board is pleased with the progress the park has made this year, i.e., getting our fiscal house in order, taking aggressive maintenance action in our water system, paving roads, managing the timber

harvest, etc. and we anticipate an equally busy 1998-1999.

### Board of Directors Meeting Minutes May 10, 1998

The Board of Directors meeting was called to order at 8:30 a.m. by Del Wallis. Prayer was led by Richard Bonner. Those present were Del Wallis - President, Jim Morrison - Vice President, Richard Bonner - Treasurer, Deena Hague - Secretary, Fred Coleman, Robert Snell, Greg Brown, and Gene Reed. Those absent - Ron Hawke, excused.

MINUTES - The minutes were read and approved. Motion by Morrison, second by Hague to approve the minutes of the April meeting as mailed. Motion carried and so ordered.

GUESTS BEFORE THE BOARD - (1) Glenn Caldwell, Insurance Services. A.F. Wilson Insurance, presentation and proposal for insurance. There are some problems with our current coverage in his opinion. (2) Buzz McCown, from Sonora Insurance Agency - same cost as last year. Two proposals - Board to be contacted after added information comes in. Motion by Brown, second by Coleman to switch insurance from Sonora Insurance Agency to Glenn Caldwell Insurance Services barring any unforseen changes -- Motion carried and so ordered.

### MEMBERS BEFORE THE BOARD - None.

CORRESPONDENCE - (1) Lorraine Nicholson would like one of the two employees on duty on weekends for convenience of people coming up on weekends. Note: Caretakers are here for contact on weekends on an <a href="immediate need">immediate need</a> basis only. They do their jobs during the week. If there is a problem, send a letter to the Board and we will address the problem. (2) Request by Byron Hofmann - new member to park - requesting use of lodge facility on Saturday, June 20, 1998, for Townsend Opera Players board of directors. Motion by Brown, second by Hague to allow this use of the Hall. Motion carried and so ordered. (3) Six proxies sent to Richard Bonner for board. (4) Bill from S&K - They said it was not paid; it was. (5) Insurance company concerning Paul Jones Logging. Insurance no longer in force.

### **COMMITTEE REPORTS**

WATER - Morrison - Water usage this past month was 97,000 gallons. Pump was installed on well six. After the pump was installed, water was sent to be tested. Company contacted to test tank and estimate repairs needed. When test comes back on well six, it will be put on line. Probe tubes will be put down well number five; this will allow us to check water level.

ROADS - Reed - Road work to be done this year include Jordan West and Jordan East and Miriam up to Esther. Do Moses around gate and area where we dug out for water repair. Those contacted were T.C Striping, Trinity, and Reed. Two bids came

in. The bids were discussed. Reed and T.C. Striping bids were about the same; only a few hundred dollars difference, but Reed a few hundred dollars more to do more work. Motion by Coleman, second by Snell to let Reed to the road job when weather permits and also to have Reed repair areas off Wheeler Road where feathering done and in need of repair. Motion carried and so ordered. Total job of \$57,730.00 -- this does not include the feathering.

BUILDINGS - Hawke (absent) - Painting upstairs is completed. Track lighting has been installed. Map of water lines posted and changes added. Stove in caretakers cabin is fixed. Building cleaned up -- snack shack. Need electrical work on lighting in the barbeque area and play area. Sign coming in at the gate -- to light new sign and possibly add speed limit sign also.

TIMBER - Coleman - Bids came in in April after the Board meeting. Del Wallis contacted members of the Board by phone and Tanner Logging was selected - to start October 1 and end October 15. Tanner did logging for us in 1997 and did a good job; few problems. Outline of Timber report by Craig A. Tolmie for General Meeting discussed. A summary will be given only. RECREATION - Snell - Saturday at 6:00 p.m. start working on Spaghetti Feed. Cost \$5.00 for adults. This meal is on Saturday, May 25th. Fish Derby is June 13.

**HEALTH AND SAFETY - Hague -** Health Department was contacted about garbage left around one of the houses.

FINANCE - Bonner - Misprint in proposed budget in timber reserve fund -- there is \$125,281 not the \$43,917 shown on the budget sent out. This was a simple misprint. Bills for this month \$14,023.14 and also an insurance fee of roughly \$13,000 and Cedar Ridge Electric Company of roughly \$2700.00 Motion by Snell, second by Reed to pay all bills. Motion carried and so ordered.

**EQUIPMENT - Brown -** Calm year. Not many problems. Blades and chains have been sharpened. All equipment in good repair. International flat bed checked -- ready to move brush. **OLD BUSINESS -**

NEW BUSINESS - Mike Caropresso before Board. Concerns about some aspects of job. Problem with his new status and pay due to his insurance. Motion by Reed, second by Morrison to increase Mike and Randy by \$75.00 a month each. This is \$75.00 a month for Mike's insurance and \$75.00 a month for Randy's IRA. Motion carried and so ordered.
