

### **Lot Inspections**

CAL FIRE (CDF) lot inspections begin on June 19<sup>th</sup> 2007.

### **Beach and Road Temporarily Closed**

On Saturday June 30<sup>th</sup> 2007 the beach at the pond and a portion of Jordan Way West will be closed for most of the day for a wedding. The beach and road will reopen for general use late in the afternoon that same day.

### **Unusually Extreme Fire Danger!**

Due to unusually little rain and snow during the past seasons, about 29% of normal, an unusually extreme fire danger will exist this summer and fall. Use extra care this year and consider additional clearing, thinning, and pruning around your lot. For clearing, thinning, and pruning information see "Lot Inspections" on this page.

### Off Road Vehicles, ATVs, Dirt Bikes, and Etc.

Off Road Vehicles, ATVs, Dirt Bikes, and Etc. are **ONLY** allowed on the dirt road that starts at the end of Isaac. runs past the water tank, and connects with the Forest Service Road System (dirt and gravel roads) just past the OFSRA boundary. Off Road Vehicles, ATVs, Dirt Bikes. and Etc. are **NOT** allowed on any other dirt road within the park, the OFSRA forest, nor any OFSRA paved road.

To enjoy the Forest Service Road System and forest, trailer your vehicle to the end of Isaac, and begin your journey from there. Isaac is located near the southeast corner of the park off Abraham. See Sierra Park maps: http://www.varvayanis.com/sp/maps.htm.

# Board of Directors Meeting Minutes May 19, 2007

The Board of Directors meeting was called to order at 8:30 A.M. by President Charles Varvayanis. The invocation was offered by Alan Orth. Those present were President Charles Varvayanis, Vice President Mike Ford, Secretary Mike Rainwater, Treasurer Doris Selman, Members, Alan Orth, Steve Wallace, and Sue Collie. Absent were Clark Kellogg and Tom Clark, excused.

Members before the board: None.

Minutes: Motion to approve the minutes of the April 21, 2007 meeting was approved as presented for the newsletter.

**Correspondence:** 1) Water information and newsletter, 2) Response by President Varvayanis via e-mail to Ms. Kasper, 3) Forest Stewardship workshop information, 4) Information from U.S. postal service, 5) Information from AT&T, 6) Information on property available on the Russian River, and 7) donation from Danny & Donna Vierra \$100.00 for the fishing derby.

### **Committee Reports**

Water - Rainwater: Water usage was 507,400 gals. The water line and water value at the Goff residence was repaired.

Roads - Wallace: Repair to the foot bridge on Westside of lake is on hold until the weather gets better.

Buildings - Kellogg: A complete list of repairs for the Park buildings was presented.

**Timber – Ford:** President Varvayanis presented Will Dorrell's report timber harvest estimates. After presenting the information, the Board agreed to present the harvest information at the Annual meeting for a vote from the OFSRA members to harvest or not.

**Recreation – Clark:** Tom reported that volunteers are needed for the fishing derby. Sign-ups for the derby will be at 6 A.M. on June 16th at the lake as well as at 5 P.M. till 7 P.M. on Friday the 15th of June at the Lodge.

**Health & Safety – Varvayanis:** 1) Fire at the front gate caused by students from Columbia College. They were burning trash. Law enforcement officials located the students and along with CDF, had the students clean up the mess. President Varvayanis was directed by the Board to contact CDF and ascertain the students' names in order to bill them for the damage to the roadway. 2) There have been unknown trespassers camping at the Park's old sand pit. No trespassing signs have been posted and if the problem continues, the Sheriff's Dept. will be contacted.

**Equipment – Orth:** 1) Requested that the Board purchase rear tires for the back-hoe. Board agreed and tires will be ordered.

**Finance – Selman:** Motion by S. Collie and seconded by Ford to pay the bills as presented. There were \$27,440.88 in bills and \$451.00 in additional income. Motioned passed unanimously. The reason for the large amount of bills was due to our insurance bill coming due which was \$22,892.07. There is still one double assessment outstanding. This assessment will be processed through small claims court.

**Old Business:** 1) The letter from Richard and Irene Barret concerning the replacement of their retaining wall was addressed and no further action is needed by the Board. 2) The playground and the amount of chips needed to insure proper depth was discussed and an additional amount will be ordered with the original order to be delivered within the next week. 3) Last day for the pine needle dump to be open will be June 18<sup>th</sup> and it will close at 4:30 P.M. that afternoon. Lot inspection will begin on June 19<sup>th</sup>. 4) Motion to repair (in house) the foot bridge on the eastside of the lake was made Orth and seconded by Ford. Motion passed with 5 yes, 1 no, and 1 abstain.

**New Business:** 1) The Long Barn-Sugar Pine Road through Cedarbrook was discussed and several issues of blockage were mentioned. Mr. Rainwater was asked to contact the owners and make arrangements to resolve these issues.

Other Business: None.

Next meeting is on June 23<sup>rd</sup>, 2007 at 8:30 A.M.

Being no further business, the meeting adjourned at 12:05 P.M.
