BOARD OF DIRECTORS MEETING - SEPTEMBER 11, 1988

The Board of Directors meeting was called to order at 9:00 AM by President Robert Hintz. All members were present except Bradley, excused.

MINUTES - Minutes of August 7, 1988 B.O.D. meeting were read and approved.

CARETAKERS REPORT - General maintenance done, water system maintenance, road repairs, equipment repairs, garbage clean up & recreation hall maintenance.

CORRESPONDENCE: 1. Letter from Yosemite Title - Title change lot 46 block 11, G & D Slater to T & T Flavin. Referred to bookkeeper for action. 2. Letter from Tuolumne County Planning Department for use permit to Alameda Boy Scout Council to construct combination lodge bunkhouse on the South Side of Jordan Way, assessors parcel #31-010-19. There will be a public hearing on this matter on Sept. 21 at 7:30 PM at the County Administration Center, Sonoma - all interested parties are welcome to attend. Member Bert Johnson has agreed to attend this meeting as the park representative. 3. Letter: new address for Rudolph Mueller 7931 B. Arguello, Stockton 95209 - referred to bookkeeper. 4. Letter from W. Tracy re: miscellaneous park matters. 5. Letter from M. Balanisi re: miscellaneous park matters. 6. Letter from R. Rasp thanking B.O.D. for their consideration.

COMMITTEE REPORTS ROADS - Bradley - All roads repaired. Patching of holes to be completed during the coming month.

TIMBER - Smith - Will contact timber people re: beetle infested trees that have appeared since last cutting. Property owners should be aware of the beetle infestation and remove all dead trees on their property or the infestation will be spread. Professional tree removal services are available - consult the local phone book.

BUILDINGS - Mitchell - Received three bids for painting park buildings. New siding to be put on the south side of the rec. hall by the caretaker.

HEALTH AND SAFETY - Garner - Requested that next year when traffic bumps are installed that one be placed on Jonathan way.

RECREATION - Armstrong - The annual steak barbecue was very successful. The board would like to thank Barbara Armstrong and her committee for their hard work which contributed to very successful barbecue. A good time was had by all who attended.

EQUIPMENT - Armstrong - An electric jackhammer for maintenance purposes has been requested by the caretaker. Member Pernetti was appointed to check prices on this and report back to the board at the next meeting.

WATER - Pernetti - Water usage for the month was 2,595,460 gallons. Spring will be run during summer months for bacteria control. All water systems are functioning well.

FINANCE - Zobel - Income from homeowners association \$22,575.00. Payroll tax refund \$30.52. Homeowners expenses \$1792.50. Timber Fund Expenses \$2814.00. Recreation Association expenses \$10,171.10. Motion by Brink, Sec. by Smith that all outstanding bills be paid - Passed.

MEMBERS BEFORE THE BOARD - Member Johnson recommended closing the road from Jordan Way East to the toboggan run and West to the spring well. Road closed and no parking signs should be posted. No action taken at this time.

OLD BUSINESS - Motion by Pernetti, sec. by Garner to have G. Mitchell investigate the bids for painting the park buildings and give him permission to take the best bid. After discussion the motion passed. Member Brink inquired as to whether any action has been taken on improving street signs. The matter is still being worked on. Homeowners are urged to post their house numbers where they can be seen from the road.

NEW BUSINESS - A motion by Brink, sec. by Mitchell to appoint B. Zobel to be the representative to the Homeowners Association. Motion passed.

Member Pernetti complained of dust from vehicles on the roads.

Homeowners are reminded that THE U.S. FOREST SERVICE HAS CLOSED ALL BACK ROADS DUE TO THE HIGH FIRE DANGER. ANYONE FOUND ON THE BACK ROADS IS SUBJECT TO A FINE RANGING FROM \$500.00 TO \$1,500.00.

CITATIONS ARE BEING ISSUED BY THE U.S. FOREST SERVICE. THIS INCLUDES PARK PROPERTY AND INCLUDES FOOT TRAFFIC AS WELL AS VEHICLES. SEVERAL CITATIONS HAVE ALREADY BEEN ISSUED.

Member Zobel informed us that the Recreation Association audit report is available for inspection by any homeowner in the park office or in the office of George Flavin, E.A.

There being no further business, the meeting was adjourned at 11:30.
