REGULATIONS FOR ODD FELLOWS RECREATION ASSOCIATION AND HOME OWNERS ASSOCIATION

PURPOSE: TO CREATE A PARK ENVIRONMENT ALL OUR MEMBERS CAN ENJOY!

- 1. The picnic area is for the use of members of the Association, guests of members, and traveling Odd Fellows. The area is available for use during daylight hours, sunrise to sunset. To assure the enjoyment of this area by all, the following activities are prohibited:
 - 1.1 The operation or parking of any motor vehicle in the picnic area. Vehicles must be parked at the road side.
 - 1.2 The operation of any device (radios, generators, etc.) that emit noise and spoil the enjoyment of the area by others.
 - 1.3 Removal of any equipment from the area.
- 2. The recreation hall is for the use and enjoyment of the members and guests. Members may make requests to the Board of Directors for use of the recreation hall. It is the responsibility of the Board of Directors to set the required deposit and rental rates. The Board of Directors shall determine the suitability of all requests for recreation hall use.
- 3. Improper operation of any motor vehicle in the park is not permitted.
 - 3.1 Operation of motor vehicles with modified exhaust systems that cause excess noise or pose a danger of emitting sparks is not allowed. Excess noise is 80 DBA or more. Exhaust systems must conform to U.S. Forest Service regulations. The caretaker has a sound level meter and will, at the request of a member, measure suspect exhaust systems.
 - 3.2 All state and local regulations governing operation of motor vehicles are in effect in the park.
 - 3.3 Vehicle operators must obey the posted 20 MPH speed limit.
 - 3.4 Vehicles <u>must</u> be parked off the paved roadway in winter. The caretaker is authorized to have vehicles towed away at the owner's expense, if they are blocking snow removal. Members not having off road parking should consult the caretaker for the nearest designated parking area.
- 4. The garbage bin is for wet hoxes, old carpets, building materials, and other burnables cannot_be_permitted. This service represents 10% plus of our annual budget. The Board of Directors reviews this service periodically and when it is no longer economical, it will be discontinued.
- 5. Members are required to comply with County and Forest Service regulations by keeping their lots free of debris.
 - 5.1 A 30 foot area clear of needles and leaves around all buildings must be maintained for fire safety.
 - 5.2 Disused appliances and vehicles are not to be stored on lots. This is in violation of County Ordinances.
- 6. Members are requested to conduct themselves in a manner that will not disturb or offend others using the park.
 - 6.1 Nude swimming is not allowed in the lake.
 - 6.2 Playing loud radios or any sound source within the park is prohibited.
 - 6.3 County leash laws for dogs are enforced in the park. Dogs, on or off a leash, are not permitted around the lake.
 - 6.4 Firearms shall not be discharged within the park.
 - 6.5 The park is a residential development. Commercial activity is not permitted.
- 7. Quiet time in the park, before 8 a.m. and after 11 p.m., will be enforced. After a warning by the caretaker, he will, at his discretion, call the sheriff's department.
